EXECUTIVE ORDER NO. 01-2022

"ORDERING TEMPORARY PROHIBITION OF THE ENTRY OF HOG BUYERS AND DEALERS OF SWINE, PORK PRODUCTS AND BY-PRODUCTS, AND IMPLEMENTING GUIDELINES ON MOVEMENT OF SWINE AND PORK PRODUCTS AND PORK BY-PRODUCTS TO PREVENT POSSIBLE OUTBREAK OF AFRICAN SWINE FEVER (ASF) IN THE MUNICIPALITY OF SANTA ANA, CAGAYAN"

WHEREAS, Sec. 16 of Republic Act No. 7160 otherwise known as the Local Government Code, empowers LGUs to exercise power necessary and appropriate or incidental for its governance towards promotion of the general welfare;

WHEREAS, the Municipal Agriculture Office has confirmed the occurrence of ASF mortalities at the neighboring municipalities;

WHEREAS, entry of the ASF virus would be best prevented through aggressive measures as a protection from ASF contamination of local swine population in the Municipality of Santa Ana, Cagayan;

NOW THEREFORE, I NELSON P. ROBINION, Municipal Mayor of Santa Ana, Cagayan, by virtue of the powers vested in me by law, do hereby order the following:

SECTION I – The temporary ban on the entry of Hog Buyers and Dealers of Swine, Pork Products and By-Products shall be strictly enforced, and <u>outbound</u> transport and movement of live hogs, frozen and processed pork is prohibited.

SECTION II - The following guidelines shall be observed and maintained as a precautionary measure to prevent possible outbreak of ASF in the municipality; to wit:

- 1). All live animals coming from outside municipalities and provinces shall pass the procedure set by the Office of the Municipal Agriculturist and secure the Ante-Mortem Inspection Certificate prior to slaughtering.
- 2). All animals to be slaughtered shall pass at the Municipal Slaughterhouse. No person shall be allowed to slaughter their animal in their respective houses even for special occasion.
- 3). Meat vendors are not allowed to buy live hogs outside the municipality. They shall secure a Barangay Certification from the PB that hogs/animal for slaughter was sourced out from their barangay.
- 4). Meat shops shall secure Permit to Sell Meat Products at the Office of the Mayor. Meat vendors must strictly follow the pricing system set by the Sangguniang Bayan through SB Resolution.
- 5) All meat to be sold at the meat market and meat shops shall follow the rules and regulation on hygienic handling and slaughtered meat. Meat vendors shall at all times display their meat products using enclosed container/ice chest/cooling facility.

- 6). Persons and entities engaged in handling sale of meat products must be licensed, having a Certificate of Attendance in Hygienic Handling of Meat.
- 7). Butchers, meat vendors/dealers shall secure Veterinary Health Certificate at the Office of the Municipal Agriculturist prior to slaughtering of animals, otherwise, NO VETERINARY HEALTH CERTIFICATE, NO SLAUGHTERING OF ANIMAL.

SECTION III – The Municipal Task Force Against ASF organized pursuant to Municipal E.O. No. 05-A, S. 2021 are expected to carry out functions accordingly.

SECTION IV- EFFECTIVITY.

This ORDER shall take effect immediately and be in force until amended, repealed, or a new order be issued.
