EXECUTIVE ORDER NO. 26-A
Series of 2022

“AN ORDER STIPULATING OWNERSHIP OF MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT FOR HEALTH (DRRM-H) OPERATION CENTER”.

WHEREAS, geographical location of the municipality of Santa Ana is vulnerable to natural disaster such as typhoon, floods and landslide, as well as human induced disaster that pose a threat to the lives and properties of the people of Santa Ana;

WHEREAS, it is highly imperative to address disasters, examine the vulnerable elements in the community, adopt measures to reduce risks and put in place a holistic natural and man-made adversities before, during and after more importantly even during normal situations;

WHEREAS, Section 16 and 17 of RA. 7160 mandates Local Government Officials to provide basic services to include the general welfare of the constituents;

WHEREAS, Administrative Order 168 Series of 2004 entitled “National Policy on Health Emergencies and Disasters” indicates that all health facilities should have an Emergency Management Office/Unit/Program;

WHEREAS, established of a functional DRRM-H system includes a functional hub or an emergency operations center for command and control, communication, and coordination;

NOW THEREFORE, I NELSON P. ROBINION, Municipal Mayor of Santa Ana, Cagayan, by virtue of the power vested in me by law, do hereby **STIPULATE OWNERSHIP OF MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT FOR HEALTH (DRRM-H) OPERATION CENTER**.

SECTION I – Location. The Operation Center (OpCen) for Health Emergencies/Disaster shall be situated within the Rural Health Unit Building designating specific room to facilitate good communication and coordination with the other agencies.

SECTION II – Functions. The OpCen shall have the following functions:

- 2.1. Monitor all health and health-related events on a 24/7 basis in the municipality, including all events and gatherings that may have a significant impact on health;
- 2.2. Monitor all DOH implementation and response efforts to activation of Code Alerts (white, blue, red);
- 2.3. Prepare timely reports as needed by the situation and properly disseminate to any concerning agencies, including but not limited to the Provincial DOH Office and the MDRMO;
- 2.4. Coordinate all health-related response efforts to major emergencies and disasters;
- 2.5. Facilitate the issuance of appropriate warnings to the Responsible Officer (Municipal Mayor) and health facilities in anticipation of impending emergencies;
- 2.6. Coordinate and monitor the mobilization of all technical experts and all types of medical teams needed in the affected areas;

- 2.7. Coordinate and monitors the mobilization of all logistical requirements needed in the affected areas;
 - 2.8. Ensure that communication equipment (e.g., radio, mobile phones) are at any time available, functional, and ready for use in emergencies and disasters;
 - 2.9. Utilize various information and communication technologies (ICT) in the dissemination of early warning and other appropriate information of stakeholders and the public;
 - 2.10. Address public queries appropriately and serve as the health hotlines as need arises;
 - 2.11. Document all health emergencies and disaster and ensures proper storage and filling of all important documents;

SECTION III – Repealing Clause. All other orders, rules, regulations and issuances or parts hereof which are inconsistent with the Executive Order are hereby repealed or modified accordingly.

SECTION IV - Effectivity. This order shall take effect immediately and it shall remain in effect unless revoked or amended.
