**EXECUTIVE ORDER NO. 37-2022**

**“CREATING THE MUNICIPAL ANTI-DENGUE TASK FORCE IN THE MUNICIPALITY OF SANTA ANA, CAGAYAN”**

**WHEREAS, the Philippine Constitution declares that the state shall protect and promote the health welfare of people, among others;**

**WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates Local Government Units to promote health and safety of its constituents by providing measures for the prevention and control of diseases, and provide assistance to those afflicted;**

**WHEREAS, DILG Secretary Eduardo M. Año issued Memorandum Circular No. 2019 dated August 9, 2019, re: Advocacy on the Prevention of Dengue and other Mosquito-Born Diseases;**

**WHEREAS, RHU-Santa Ana, Cagayan has recorded dengue cases since January 2022, which, at all cost need not increase further;**

**NOW THEREFORE, I NELSON P. ROBINION, Municipal Mayor of Santa Ana, Cagayan, by virtue of the power vested in me by law, do hereby order:**

**SECTION I – The Municipal Anti-Dengue Task Force of Santa Ana, Cagayan shall be created, composed of the following:**

## **SECTION II – Function of the Municipal Anti-Dengue Task Force.**

- 1. Advocate to their constituents to actively participate in the massive information drive against dengue.**
- 2. Conduct simultaneous Clean-up Drive in all barangays.**
- 3. Distribute IEC materials and other informative propaganda against Dengue and Mosquito-Borne Diseases in the schools and barangays of the municipality.**
- 4. Establish Surveillance and Vector Control through the Municipal Health Office.**
- 5. Provide technical and logistics support to the Barangay Anti-Dengue Task Force Teams.**
- 6. Institutionalize recording and reporting system for Vector Control and Surveillance Information, and evaluate the LGU response and preparedness.**

**This Order shall take effect immediately and remain in force until amended or repealed.**
