## **EXECUTIVE ORDER NO. 10-2021**

**“AN ORDER REORGANIZING THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC) OF SANTA ANA, CAGAYAN.”**

WHEREAS, Joint Memo Circular No. 2010-1 mandates the creation of the Local Committee on Anti-Trafficking and Violence Against Women and Their Children (LCAT-VAWC) AT THE Municipal Levels;

WHEREAS, the general purpose of creating the LCAT-VAWC is to establish and strengthen local structure that will collaboratively address the problem of Trafficking and Violence Against Women and Their Children;

- b. Create and establish systems on surveillance, investigation, and rescue to ensure effective and efficient coordination.
  - c. Undertake information, education, and advocacy campaign against trafficking of persons and Violence Against Women and Their Children (VAWC).
  - d. Monitor and oversee the strict implementation of Republic Act No. 92508, Republic Act No. 9262 and other related laws for the protection of women and children, and of the IACAT and IACVAWC national plans, and
  - e. Implement the programs and activities as stated in the national plan of action.

### **SECTION III – Effectivity**

This Order shall take effect immediately and be in force until amended or repealed.
