EXECUTIVE ORDER NO. 11-2021

“REORGANIZING AND REINFORCING THE LOCAL IATF AGAINST COVID -19 OF THE MUNICIPALITY OF SANTA ANA, CAGAYAN.”

WHEREAS, IATF Resolution No. 101, dated February 26, 2021 was issued approving the uniform travel protocols for land, air and sea;

WHEREAS, the recent spike in the number of active COVID-19 cases monitored by the DOH, and the newly-discovered strains of the corona virus, a Memorandum Circular was issued reiterating LGUs to adopt lawful measures to implement minimum health standards and enforcement of penal provisions for NON-COMPLIANCE to health and safety protocols;

WHEREAS, DILG Memorandum Circular No. 2021-035 dated March 24, 2021 directs all LGUs to review existing ordinances relating to mandatory testing and quarantine protocols in compliance with IATF Resolutions and Memorandum Circular No. 2021-035, and include therein appropriate fines and penalties in case of violations;

WHEREAS, compliance to minimum safety and health standards must be strictly enforced with corresponding penalties to violators, hence, the composition of the Local IATF be reinforced to perform functions in preventing spread of the dreaded virus;

WHEREAS, several members of the Task Force have retired/transferred to other areas and are no longer around to perform duties and functions in Santa Ana;

NOW THEREFORE, I NELSON P. ROBINION, Municipal Mayor of Santa Ana, Cagayan, by virtue of the power vested in my by law, do hereby order:

SECTION II – Functions

A. On Containment

- 1. Monitor the persons arriving from affected country/countries through the Barangay Officials.**
- 2. Monitor measures & actions taken by the Punong Barangay and BHERTs in preventing, containing & controlling corona virus.**
- 3. Provide logistical assistance to the logistical assistance to the BHERTs in carrying out their tasks.**
- 4. The MHO as co-chairman will supervise the BHERTs & submit report/s to the PHO on the outcome of containment/ home confinement.**
- 5. Assist in referral & transportation of corona suspects to the DOH designated referral center or hospital for corona virus.**
- 6. Seek assistance of the PNP or the Punong Barangay to effect the compulsory home confinement of persons arriving from corona virus-affected areas country who VIOLATE HOME CONFINEMENT to complete the 14-day prescribed period, in case the Punong Barangay & BHERT fail to impose the home confinement of 14 days.**
- 7. Extend appropriate assistance & support to those in home confinement, depending upon the confinee's capability & actual needs.**

B. On Prevention

- 1. In coordination with the DOH/PHO, train Municipal Health Workers, especially hospital or RHU Personnel in handling and managing corona virus suspect.**
- 2. In coordination w/ DOH and/or PHO, provide training to the local health workers, BHERTs members and Brgy. Tanod on corona virus prevention, containment & control.**
- 3. In coordination w/ the DOH, DILG, PNP, PHO as the case may be, provide training to local health workers, BHERTs members & brgy. tanods in enforcing the 14-day confinement procedures for persons arriving from corona virus affected country.**
- 4. Conduct a Municipal Wide Campaign on corona virus prevention, containment & control.**
- 5. Coordinate with Punong Barangays in the conduct of municipal wide clean-up campaign.**
- 6. Coordinate w/ LPCC(Local Price Coordinating Council) in monitoring prices of medicines and corona virus preventive gadgets, and file charges against over pricing or hoarding.**
