



EXECUTIVE ORDER NO. 18-2021

“AN ORDER PRESCRIBING GUIDELINES TO BE OBSERVED IN ALLOWING BUSINESS ESTABLISHMENTS, PERSONS OR ACTIVITIES TO OPERATE, WORK OR BE UNDERTAKEN UNDER THE GENERAL QUARANTINE STATUS OF SANTA ANA, CAGAYAN.”

WHEREAS, Section 15, Article II of the Philippine Constitution provides that it is the policy of the state to protect and promote the right to health of the people;

WHEREAS, a State of Public Health Emergency was declared throughout the Philippines by virtue Proclamation No. 922, S. 2020 due to the Corona Virus Disease (COVID-19) pandemic, and enjoined all government agencies and LGUs to render full cooperation, appropriate response and measures to eliminate the threat and spread of the virus;

WHEREAS, the Municipal Government of Sta. Ana IATF was organized to respond/provide services and implement measures compliant to National IATF guidelines to contain the spread of COVID-19;

WHEREAS, pursuant to the declaration of the Province of Cagayan under the GCQ status, protocols had been adopted under Municipal Executive Order No.13-2021, in compliance with the OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES with Amendments as of April 15, 2021;

WHEREAS, the Municipality of Santa Ana, a Tourist Hub shall allow limited operation of business establishments, in compliance to DTI Memorandum Circular No. 21-15, S. 2021, considering the petition of SAHARA and Tourism Related Business;

NOW THEREFORE, I NELSON P. ROBINION, Municipal Mayor of Santa Ana, Cagayan, by virtue of the power vested in me by law, do hereby order:

The following business establishments/activities shall be allowed to operate work or be undertaken under the GCQ status, pursuant to DTI MC No. 21-15, S. 2021, to wit:

CATEGORY IV-

Amusements, recreational venues, lottery, betting shops, etc. (NOT ALLOWED)

ALL OTHER ACTIVITIES not mentioned herein shall be limited pursuant to the OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES w/ Amendments as of April 15, 2021.

THIS ORDER shall take effect immediately and remains in force until a superseding or amending order be issued.
