EXECUTIVE ORDER NO. 24-2021

“AN ORDER LIFTING THE LOCKDOWN STATUS AT THE MUNICIPAL PUBLIC MARKET AND IMPLEMENTING ALTERNATIVE PREVENTIVE MEASURES AGAINST COVID-19 AT THE MARKET AREA.”

WHEREAS, Municipal Executive Order No. 23-2021 was issued as a preventive strategy to deflect the spread at the feared corona virus;

WHEREAS, controlling the influx of crowds in the area should be maintained, while economic activities of people remains unhampered;

WHEREAS, the Municipality must strictly implement the Guidelines pursuant to the OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES WITH AMENDMENTS AS OF MAY 20, 2021 issued by the IATF;

NOW THEREFORE, I, NELSON P. ROBINION, Municipal Mayor of Santa Ana, Cagayan, by virtue of the power vested in me by law, do hereby order:

SECTION 1 – Upon Lifting of the Lockdown Status, Schedule of Procuring Goods at the Public Market shall be as follows:

a). Monday-Wednesday-Thursday-Friday

Barangay Casambalangan	Barangay Centro
Barangay Rapuli	Barangay Palawig
Barangay Diora-Zinungan	Barangay Santa Cruz
Barangay Tangatan	Barangay San Vicente

b). Tuesday-Saturday-Sunday

Barangay Parada-Batu	Barangay Casagan
Barangay Marede	Barangay Dungeg
Barangay Visitacion	Barangay Santa Clara
Barangay Kapanikian	Barangay Patunungan

c). It shall be the responsibility of the Barangay Officials to disseminate and ensure management of people’s movements within their areas of jurisdiction, in observing the above schedule.

SECTION 2 – The regular activities at the Municipal Slaughterhouse shall be resumed and all home-based slaughtering activities be banned.

SECTION 3 – The OPLAN FASOC MO and other Ordinances in the Observance of Health Protocols shall be strictly imposed particularly, among vendors and business establishment personnel/manpower and people going-in at the market place.
