**EXECUTIVE ORDER NO. 27-2021**

**“CREATION OF THE LGU INSPECTION AND CERTIFICATION COMMITTEE OF THE MUNICIPALITY OF SANTA ANA, CAGAYAN”.**

**WHEREAS, Section 15 Article II of the 1987 Philippine Constitution mandates that the State shall protect and promote the right to health of the people and instill health consciousness among them;**

**WHEREAS, to contain the spread of COVID-19 and prevent future surges, there is a need to enforce strict and continual compliance with the Minimum Public Health Standards (MPHS) especially in business establishments and major public places;**

**WHEREAS, The Safety Seal Certification Program (SSCP) provided in the IATF Resolution No. 87 series of 2020 aims to increase compliance by private or public entities with the minimum public health standards set by the government;**

**WHEREAS, the Safety Seal is a physical manifestation of the compliance of an establishment to the minimum health standards required by the government to contain the spread of COVID-19;**

**WHEREAS, under the DOLE-DOH-DILG-DOT JMC 2021-01 otherwise known as IMPLEMENTING GUIDELINES OF THE SAFETY SEAL CERTIFICATION PROGRAM, Local Government Units are designated as Issuing Authorities vested with the authority to inspect private establishments assigned to it and to issue and/or to revoke the Safety Seal;**

**NOW THEREFORE, I NELSON P. ROBINION MUNICIPAL MAYOR OF SANTA ANA, CAGAYAN, by virtue of the power vested in me by law, do hereby organize/create the LGU Inspection and Certification Committee, as provided hereunder;**

**SECTION I- COMPOSITION:**

**The LGU Inspection and Certification Committee shall be constituted with the following composition:**

**The Committee may create as many inspection teams as maybe necessary depending on the number of business establishments in the LGU.**

## SECTION II- COVERAGE

Pursuant to Joint Memorandum Circular 21-01, the LGUs are directed for the issuance of Safety Seals in the following establishments: Malls, Wet Markets, Other Retail Store, Restaurants outside Hotels/Resorts, Fast foods, Eateries, Coffee shops, etc; Banks, Money Changers, Pawnshops,

Remittance Centers, Car Wash, Laundry Service Centers, Art Galleries, Libraries, Museums, Zoo, Sports Centers, Tutorial, Testing and Review Centers, Gyms, Spas, Cinemas, Arcades, and all other private establishments.

## SECTION III- EFFECTIVITY

This Executive Orders takes effect immediately.
