#### **EXECUTIVE ORDER NO. 28-2021**

"AN ORDER IMPLEMENTING IATF RESOLUTION NO. 125 OR GENERAL COMMUNITY QUARANTINE (GCQ) UNDER HEIGHTENED RESTRICTIONS IN THE MUNICIPALITY OF SANTA ANA, CAGAYAN".

WHEREAS, Section 5, Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 2 (b) of E.O. No. 168 (s. 2014) mandates the Inter-Agency Task Force for the Management of Infectious Diseases (IATF) to prevent and/or minimize the entry of suspected or confirmed patients with emerging infectious diseases into the country;

WHEREAS, on September 16, 2020, President Rodrigo Roa Duterte issued Proclamation No. 1021, S. 2020, extending the period of the State of Calamity throughout the Philippines, until September 21, 2021;

WHEREAS, the DOH, UP-PGC and UP-NIH biosurveillance has detected and received information on the existence of COVID-19 variant (DELTA virus) in the Philippines;

WHEREAS, the Province of Cagayan and the Municipality of Santa Ana, Cagayan had been declared under GCQ Status under Heightened Restrictions which require continued implementation of proactive measures and restrictions to be put in place and stop further spread of variants, by time for the health system to cope, and to protect more lives;

NOW THEREFORE, I NELSON P. ROBINION MUNICIPAL MAYOR OF SANTA ANA, CAGAYAN, by virtue of the power vested in me by law, do hereby order:

SECTION I- The IATF Guidelines under Resolution No. 125, issued on July 8, 2021 shall be strictly observed, particularly, the following:

- A. In areas under MGCQ and GCQ Under Heightened Restrictions,
  - 1. Children 5 years old above may be able to go to outdoor areas, provided the child is supervised by adults and observe MINIMUM PUBLIC HEALTH STANDARDS (Wearing of Face Masks and Social Distancing). Outdoor areas shall be limited to PARKS, PLAY GROUNDS, BIKING /HIKING TRAILS, OUTDOOR TOURIST SITES AND ATTRACTIONS ( in accordance to DOT Guidelines) OUTDOOR NON-CONTACT SPORTS VENUES and OUTDOOR DINING ESTABLISHMENTS.
  - 2. Vaccinated individuals and senior citizens may be allowed to go outdoors subject to presentation of vaccination card duly issued by legitimate vaccination establishment authority, whether local or foreign, or Certificate

of Quarantine Completion showing the holder's vaccination status, but still, strictly observing MINIMUM PUBLIC HEALTH STANDARDS.

- 3. Funerals If COVID-19 related death, the dead shall be buried within 12 hours. If not COVID-19 related death, burial may be longer, provided, gathering shall be limited to direct family members only and still observe the minimum health standards.
- 4. Social events involving large gatherings shall NOT be allowed. Religious gatherings may be allowed at 10% capacity of the church, and observance of health protocols is a MUST.

### **SECTION II – TOURISM ACTIVITIES**

Tourism Activities shall be restricted up to 30% only, provided, incoming travelers must undergo Antigen Testing. Accommodation Establishments (hotel, beach resorts, home stay inns, etc.) are mandated to coordinate with the checkpoint Personnel on the entry of guests, and coordinate the same to the Barangay Government/Officials.

### SECTION III – PUBLIC UTILITY VEHICLES

Franchise permit of PVVs is from Tuguegarao-Santa Ana and vice versa. Special permits are, however, issued for trips to Manila and other places, BUT, Drivers must still undergo Antigen Testing on their return trips.

#### SECTION IV – BUSINESS ACTIVITIES

<u>Buyers of pineapple</u> and their crew as well as <u>Fish Buyers</u> are subject to Antigen Test upon entry.

# SECTION V – AUTHORIZED PERSON OUTSIDE RESIDENCE (APORs)

Only persons with Official Business (Government transactions) are considered APOR's upon entry. They are required to present Identification Card (ID) Travel Order and Point of Destination, Health Declaration or Negative Antigen Result, otherwise, they will be required to undergo Antigen Test prior to entry.

Sea travelers from the areas outside Santa Ana (Maconacon, Isabela, Calayan Island, etc.) shall be required to undergo Antigen Test prior entry at the local ports.

Entry of Filipinos coming home (OFWs) shall be subject to the Guidelines and restrictions issued by the SWG composed of DOH, BOQ, OWWA, DOF, DOT, PCG and DOTr.

Other entrants not mentioned in the aforementioned groups shall be considered <u>Travelers</u> and therefore subject to undergo ANTIGEN TEST prior to entry in the Municipality of Santa Ana, Cagayan.

## **SECTION VI – CURFEW**

Curfew hours shall be enforced from 10:00PM to 4:00AM.

THIS ORDER shall be in full force and effect during the General Quarantine Status in the municipality.
