“STRENGTHENING AND REORGANIZING THE ARTS AND TOURISM COUNCIL OF SANTA ANA, CAGAYAN”

WHEREAS, R.A. No. 7160, Section 7, provides the LGUs play a vital role in the development and promotion and preservation of culture and arts, and encourage the participation of the people in development and preservation of tourism destination;

WHEREAS, Local Government Units are vested with the responsibility to coordinate with other government agencies, non-government entities, subject to the availability of funds for the support and development of culture, arts and tourism;

WHEREAS, the Municipality of Santa Ana is among the tourism hubs in Region 02 and proclaimed by DOT as a recipient of the “STAND ALONE POLICY” status on tourism;

WHEREAS, the organized Municipal Culture, Arts and Tourism Council needs to be reinforced as well as reorganized due to the transfer of several members to other areas, and are no longer available to perform functions with the group;

NOW THEREFORE, I, NELSON P. ROBINION, MUNICIPAL MAYOR OF SANTA ANA, CAGAYAN, by virtue of the power vested in me by law, do hereby order:
