**EXECUTIVE ORDER NO 44-A 2021**

**“AN ORDER CREATING AND CONSTITUTING THE MUNICIPAL COUNCIL AGAINST TRAFFICKING, CHILD PORNOGRAPHY AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN OF THE MUNICIPALITY OF SANTA ANA, CAGAYAN”.**

WHEREAS, R. A. # 9775, otherwise known as Anti-Child Pornography Act of 2009 declares that the youth has a vital role in nation building and the state shall promote and protect their physical, moral, spiritual, intellectual, emotional and psychological and social well being;

WHEREAS, the Anti-Child Pornography Act further guarantees the fundamental right of every child from all forms of neglect, cruelty and other conditions prejudicial to his/her development;

WHEREAS, the said Act shall also protect every child from all forms of exploitation and abuse, including, but not limited to (1) use of a child in pornographic performances, and (2) the inducement or coercion of a child to engage or be involved in pornography through whatever means;

WHEREAS, the Philippines as a signatory to the UN, Convention on the Rights of the Child Complaint to the provision of programs and services and other protective mechanisms in securing child's right and development;

WHEREAS, the Municipal Government further upholds the rights of children amplified in the enacted ordinance No. 29-2015, the Children's Welfare Code of Santa Ana, Cagayan;

NOW THEREFORE, I NELSON P. ROBINION of SANTA ANA, CAGAYAN, by virtue of the power vested in me by law do hereby order:

SECTION I – There shall be created a Municipal Council Against Trafficking, Child Pornography and Violence Against Women and Their Children of Santa Ana, Cagayan, to be composed of the following:

- 01. Formulate Plans and programs to prevent/suppress any form of child pornography;**
- 02. Conduct information disseminations and campaign on the existence of the said law;**
- 03. Assist in the filing of cases against individuals/agencies/institutions or establishments that violate the provisions of this Act;**
- 04. Coordinate programs and projects of member agencies to effectively address issues and concerns on child pornography and to report to the Council the impact/result of the actions undertaken;**
- 05. Perform such other tasks relative to Anti Child Pornography;**
