AN ORDER ORGANIZING THE MUNICIPAL RESPONSE TEAM WITHIN THE LOCAL DISASTER RISK REDUCTION AND MANAGEMNT COUNCIL OF SANTA ANA, CAGAYAN

- WHERE AS, the municipal response team will consist of three(3) clusters, namely; cluster I; search, rescue and retrieval team, cluster II; evacuation and camp management team and cluster III; warning, alerts & announcement team:
- WHERE AS, cluster I consist of four (4) teams, namely search rescue and retrieval team headed by the *Philippine Coast Guard*, security team headed by *Philippine National Police*, medical team headed by the *Municipal Health Office* and clearing operations team headed by the *MENRO*;
- WHERE AS, cluster II consist of Two (2) teams namely; evacuation camp management and mass feeding and relief distribution team headed by the MSWD office, MDRRM office and Municipal Health Office.
- WHERE AS, cluster III, the warning, alerts and announcement teams headed by the Municipal Disaster Risk Reduction and Management Office;
- WHERE AS, there is need to organize the Disaster Respond Team to strengthen
 The local government capacities on Disaster Risk Reduction and
 Management through decentralized powers, responsibilities and resources;
- **WHERE AS,** the respond team will automatically activated before an impending disaster.
- NOW THEREFORE, I NELSON P. ROBINION, Municipal Mayor, by virtue of the power vested in me by law, do hereby organize and appoint the *Municipal Disaster Respond Team* of the municipality of Santa Ana.

SECTION 2. FUNCTIONS.

1. CLUSTER I:

- a. Search rescue and retrieval of victim/s.
- b. Provide security and police visibility to the areas of concern as earlier identified to prevent lawless elements that may take advantage of the pronouncement and to monitor and help in the possible conduct of preemptive and force evacuation.

- c. Asses sick person and provide medicines to all sick person/s in the evacuation center and Conduct information, education and communication (IEC) campaign to evacuees.
- d. Conduct brushing and pruning of trees before an impending disaster and Clearing and removal of debris after.

2. CLUSTER II:

- a. Activation of Evacuation Center/s and disaster welfare inquiry desk;
- b. Master list and profile of victims;
- c. Provision of Daily Family Food packs to evacuees;
- d. Provision of non-food items and
- e. Undertake other services for evacuees.

3. CLUSTER III:

a. Disseminate warnings of an impending disaster and conduct round the clock announcements as to location, strength and possible track of the typhoon and coordinates to all barangay captains the affectivity of the provincial ordinance regarding Liquor Ban, No Sail and No Swimming Policy to the civilian populace.

This Executive Order shall take effect immediately upon its approval.
