



## EXECUTIVE ORDER NO. 05-A-2021

**“AN ORDER ORGANIZING THE MUNICIPAL TASK FORCE TEAMS AGAINST THE AFRICAN SWINE FEVER (ASF) IN THE MUNICIPALITY OF SANTA ANA, CAGAYAN.”**

WHEREAS, three (3) barangays of the Municipality of Santa Ana, Cagayan have been validated as affected areas by the ASF;

WHEREAS, implementation of measures to prevent spread of the virus to other barangays must be closely monitored;

NOW THEREFORE, I NELSON P. ROBINION, Municipal Mayor of Santa Ana, Cagayan, by virtue of the power vested in me by law do hereby order:
